Incidents

On February 2nd 2018, Officer Sutherland responded to Mill and Main Place for a report of vandalism in one of the restrooms. Upon arrival, he was met by a Mill and Main Place Security Officer who showed him damage to a wall and profanity written on the mirrors. Upon review of the security cameras, several juveniles were identified. The case was forwarded to the Detective Unit.

On February 11th, 2018, Officer Maskalenko responded to a report of a fight on Percival Street, in the middle of the road. Upon arrival Officers determined it was a male party who did not want to go inside of a residence. The matter was resolved.

On February 18th, 2018 Officer Brennan responded to Main Street to take a report of a missing person. The individual had wandered away from a family member at a local business. Officers pinged the individuals cell phone, and were given a location in Stow. Stow Police Department located this person, and he was returned to the care of a family member.

On February 28th, 2018 Officer Davoll was scanning radio traffic from an adjoining community and heard a report of a man waiving a firearm in a vehicle on Route 62. Officer Davoll was able to obtain the license plate, and the individual resided in Maynard. Officers responded to this individuals residence, and made contact with him. Through their investigation, Officers located two unsecured firearms in the vehicle. This individuals license to carry a firearm (LTC) was revoked, and the matter is still under investigation by Acton and Concord Police Departments.

In the month of February, the Maynard Police Department responded to one opioid overdose that resulted in a fatality.
