During the month of September, the Maynard Police Department was diligently preparing for the re-accreditation process. On September 18th, 19th and 20th the re-accreditation team was present in the Maynard Police Department reviewing our policies, procedures and facility. The assessment administrator explained that after a typical assessment most agencies are required to make multiple "repairs" of various standards but on very rare occasions an agency is not required to make any repairs. We are proud to announce that we do not have to make any repairs or report back to the commission. We will be officially notified of re-accreditation status within a few weeks and then publicly recognized in February.

On September 14th, MPD Officers assisted in escorting FEMA through Maynard, enroute to the Carolinas for Hurricane Florence.

Sergeant Duggan, and Detective Manchuso responded to the City of Lawrence in their NEMLEC roles to assist with the Columbia Gas incidents.
